

dedicated to supervising and creating a safe and enriching environment for the youth. Those individuals are found within Tulalip's own Youth Services activity staff.

For many years, the Youth Services activity staff have provided a safe place for students to be during the critical hours after school and on weekends, at no cost to families. Historically, the program has provided supervision of organized games and activities in a recreational setting for those youth who drop-in to the Tulalip Teen Center. Youth sign-in upon their arrival and usually stay as long as they wish, or until the announcement is made for last-call for a van ride home.

The goals of the activity staff are to provide supervised enrichment, fitness, and other sport activities in a safe neighborhood environment. They emphasize physical fitness that develops basic movement skills, strong and healthy bodies, teamwork, sportsmanship, cooperative social skills, and activities that reinforce Tulalip values. Additionally, the Youth Services program promotes

good health and positive self-esteem, while placing high importance on teaching youth to make informed decisions on how to live a healthy and proactive lifestyle.

The Youth Services mission is: As our ancestors before us, we unite as one to serve all youth by utilizing our spiritual, physical, cultural, and educational programs.


family from Blackfeet and Alaska Tribe.





# Lady Hawks finish regular season undefeated

The Tulalip Heritage Lady Hawks basketball team was 16-0 with three regular season games remaining on our last check-in. Let's recap those final three games.

On Tuesday, January 26, the girls traveled to Eastsound, WA to take on the Orcas Christian Saints. The Lady Hawks made quick work of the one-win Saints, winning 65-22.

Then on Friday, January 29, we welcomed the Grace Academy Eagles to our gym. It was a game the Lady Hawks had been preparing for, as the 2<sup>nd</sup> place Grace Academy

are the only team in the Northwest 1B league who have given us a competitive game all season. This game also had significant meaning for senior Adiya Jones, as there were several college scouts and coaches in attendance to watch her performance versus a competitive program.

In the 1<sup>st</sup> quarter, the Lady Hawks came out primed for another blowout. They pounded the ball in the post and were able to convert on several shots at the rim, while making it very difficult for the Eagles to get quality shots up. At the end of the quarter the Lady Hawks led 18-

8. But then the game tightened up. The Eagles went on an 8-0 to start the 2<sup>nd</sup> quarter, cutting the Lady Hawks lead to only 2 points, 18-16. Coach Bubba Fryberg called a timeout to get his team refocused on the game plan. From that point, the game turned into a typical Lady Hawks beat down.

A 15-4 run to close the 2<sup>nd</sup> quarter gave the Lady Hawks a 33-20 halftime lead. The entire 2<sup>nd</sup> half saw the Lady Hawks turn loose on offense and go to a whole new level defensively. It seemed liked nearly every Grace Academy pass was either stolen or deflected, to the point

the Eagles looked completely out of sorts on offense. The Lady Hawks led 55-26 going into the 4<sup>th</sup> quarter. What was once only a 2 point game midway through the 2<sup>nd</sup> quarter turned into a 71-30 blowout victory for the 1<sup>st</sup> place Lady Hawks.

Adiya Jones, fully aware of the college scouts and coaches in the building, upped her game and had a game for the ages. She had a career high 18 steals, which is very impressive in its own right, but it gets even better. Adiya finished with her first ever quadruple-double stat line of 22 points, 11 rebounds, 11 assists,

and 18 steals. For those who follow the NBA, there have been only five players in league history to ever achieve the super rare quadruple-double, the latest one being achieved by David Robinson back in 1994.

After the blowout victory over Grace

Academy, the Lady Hawks were 18-0 and only had one final regular season game remaining. On Monday, February 1, the Lady Hawks hosted the Highland Christian Knights. This game doubled as Senior Night for senior players Kaenishia Herrera, Adiya Jones, Michelle Iukes, and Desirae

Williams. Cheered on by their families and friends, the Lady Hawks went on to win 52-23 and finish the regular season undefeated at 19-0.

Next up for the Lady Hawks is the District 1B basketball tournament, where they will be going in as the #1 overall seed.





# Hawks end regular season on a winning streak

On Tuesday, January 26, the Heritage Hawks traveled to Eastsound, WA to play the league's 1<sup>st</sup> place team, the Orcas Christian Saints. It was a big game for the Hawks, who were looking for a statement win after losing their previous two matchups vs. the Saints. It was a highly competitive game from the opening tip, but just like the last two matchups the game would slip away from Hawks down the stretch. Saints point guard and leading scorer Michael Harris continued to give the Hawks' defense matchup problems and made timely plays for his team. The Hawks would lose 58-71 and fall to 0-3 vs. the league's best team.

The Hawks bounced back in a big way when they hosted the winless Grace Academy Eagles on Friday, January 29. From the very beginning onlookers knew it was going to be a blowout, as the Hawks executed flawlessly on both ends of the court. At halftime the Hawks held their largest lead of the season, 46-2. In the 2<sup>nd</sup> half, with such a massive lead, the coaching staff pulled their starters and let the reserves get in a lengthy run. The Hawks finished the game with a 58-18 win. They were led by Josh Iukes and Samuel Fryberg in scoring, both had 13 points.

On Monday, February 1, the Hawks held their final regular season game at Francy J. Sheldon

gymnasiums when they took on Providence Classical Christian. The Hawks had beaten Providence by at least 20 points in their previous two matchups. This would be no different. Willy Enick led all scorers with 18 points, as his Hawks won easily, 66-35.

After starting the season off with a 1-5 record, the Hawks finished the season strong by winning 11 of their final 14 games. Now, with a 12-8 overall record (11-4 in their league) the Hawks have earned a top 3 seed in the upcoming District 1B tournament.

# What We Know about Autism Spectrum Disorder

Parents often ask questions about Autism Spectrum Disorder (ASD) which is a complicated developmental disability. Over the past couple of years researchers have continued to learn more and there have been changes in how ASD is diagnosed, as well as better ability to spot early characteristics of autism.

#### Did you know?

- ASD is 5 times more common in boys than girls
- A child who has a sibling with ASD is also more likely to receive a diagnosis
- The Center for Disease Control estimates 1 in 68 children have ASD
- Children born to older parents have a higher risk of ASD
- Studies have and continue to show that vaccines are NOT associated with ASD
- Reliable diagnosis for ASD can begin as early as 2 years old
- A professional may be able to identify red flags earlier than 2 years old in some children
- Parents of children aged 16-30 months can complete a checklist (called the M-CHAT) online to see if their child shows risk factors for ASD (www.m-chat.org)

If you have a child under 3, and you have concerns about developmental delays, you can arrange a comprehensive developmental evaluation from ChildStrive at no cost.

We encourage parents to gather their own information from reliable sources such as health care professionals and reliable websites. Many parents learn about autism from other parents who have experienced similar concerns. If you have a child with autism, or concerns, you can pass knowledge on to other parents or teachers who are just learning about this developmental disability.

#### **Attention Fishermen**

Over the years we at Tulalip Fisheries have confiscated numerous nets, crab and shrimp pots for a variety of Violations. At this time we are petitioning the Tribal Court to have the gear forfeited per Tulalip Tribes Code 8.05.

Persons wishing to claim any gear will have 15 days from the last day this add runs (March 2, 2016) to put in a claim for gear.

# ANYONE PUTTING IN A CLAIM FOR GEAR WILL BE REQUIRED TO PROVIDE THE FOLLOWING

- Police Report of when gear was left or lost, area gear was left or lost, and what gear was fishing for.
- Person claiming gear will have to name person fishing gear at time. This will be checked against fishing permits. Upon any violations a citation will be issued.
- Proof of Ownership, including bill of sale, invoice, etc.
- Will be required to appear for any Court Hearing (s) for the gear you are claiming.
- May receive a Citation in all cases that gear was in violation of Tulalip Tribal Code 8.05 fines will be given for every violation to include fishing in closed waters \$500.00 fine, unattended set net \$25.00 fine, improperly marked gear \$50.00 and any other violations that apply. In cases involving crab or shrimp pots citations my be issued for not having rot cord and not being marked with Tulalip Tribes Crab Pot tags

#### Listed below are the confiscated items:

- Approximately 175 commercial crab pots in various conditions ranging from derelict gear in poor condition to gear in fair condition.
- Approximately 12 shrimp pots in various conditions.
- Approximately 35 nets ranging from approximately 10ft to 600ft with various types of Corklines, Leadlines, Webing, etc. The condition of these nets range from poor condition to fair condition.
- several fishing poles

If you believe some of this gear is yours contact one of the Fish and Wildlife staff at the Tulalip Marina.

Upon Forfeiture of any Confiscated gear by the Tulalip Tribal Court, the Tulalip Fisheries Executive Director will set an Auction date for all Forfeited items.


