Contract Health Service is on priority one funding

Clinic staff explain that priority one funding only affects referrals, not clinic services

Recent policy changes, shifting Contract Health Services (CHS) funding from priority 3 to priority 1, have tribal citizens asking Tulalip leaders, 'Isn't healthcare my right under the treaty? Do you even care if I live or die?'

"First, I want to make clear that priority 1 refers to diseases," said Health Clinic Administrator Scott Powell. "A disease can be priority one, two, through five. Every person who comes to us for health care is important."

I am sick, can I still go to the clinic?

All eligible citizens are encouraged to come to the clinic for preventative care and if they are ill. Powell explained that priority 1 doesn't affect in-clinic services, only referrals to outside providers (which includes hospitals and specialty services not offered at Tulalip). Every citizen who is currently eligible to receive services at the Karen I. Fryberg Health Clinic still has access to the health and dental professionals who practice at the clinic.

The primary driver for the change is very simple, there is not enough money to pay for the increasingly high cost of health care outside the clinic and still provide the same level of services at the clinic.

Although many in the community are upset, Tulalip has actually funded CHS at priority 3 levels far longer than most tribes. Nationally, IHS services have been on priority 1 since March of 2009. Why was Tulalip spared? Tulalip funds health services through a combination of grant and hard dollars.

Tulalip is a self-governance tribe (see sidebar) with the ability to shift IHS grant funds to any program dedicated to the health care. During the 2013 budget shortfall, grant funds were re-allocated to the Family Services program to pay for the skyrocketing number of patients in chemical dependency treatment programs. This meant less for the tribe to spend on the clinic and CHS. Changing CHS from priority 3 to priority 1 funding was a way to prevent another budget shortfall this year. Both elders and students are exempt from the priority restrictions and will continue to have access to CHS at all priority levels.

Priority levels and payment for specialists/ emergencies

The clinic is home to dentists, family practice and internal medicine doctors, even a pediatrician, podiatrist and diabetes specialist. While many services are offered on-site, some specialties are not available. When necessary, the clinic refers these cases out for care.

Why does CHS only cover certain healthcare needs? CHS is funded through IHS grants and, according to IHS regulations, is considered a payor of last resort. What is a payor of last resort? This means you must have exhausted all other available options, including private insurance, before CHS can even consider paying your medical bill.

Once you have exhausted your options, your medical situation is classified under one of the five priority levels. Priority 1 is defined

as emergent care, meaning there is a threat to life, limb, and senses. Priority 2 is preventative care, and priority 3 is primary care, such as family practitioners. There is also priority 4 and 5 which cover tertiary care, such as hospice and in home care, and excluded services, meaning services not covered by other available options.

Depending on the current priority level, CHS will then be authorized to pay for the patient's services, or will have to deny the patient's claim. If you require emergency care while the clinic is closed, you must notify CHS within 72 hours of the visit to be considered eligible for payment.

How long will we be on priority 1?

Powell and his team meet twice a month to look at available funds and projected needs to see if they can reopen CHS funding to pay for priority level 2 and 3 care. Already this year, they are \$30,000 over CHS projections. Although funding is tight now, they hope the priority 1 restriction isn't long term.

Powell said that he and his team are more than happy to sit down and discuss any questions regarding changes to CHS with anyone who is interested. He also affirmed that he and his team of providers don't hesitate to send patients to outside specialists and hospitals when necessary.

IHS grant funding and PL 638

The total budget for IHS is \$5 billion, which is portioned out to 10 regional areas. Each area office serves the tribes in its region. Tribes receive funding based on several factors including population and need. Tulalip is served by the Portland area office.

The CHS program at Tulalip is grant funded similar to IHS clinics across the nation, though as a PL 638 compacted tribe, also known as a self-governance tribe, Tulalip has some control over funding allocations. PL 638, or Public Law 93.638 which recognizes tribes as self-determined sovereigns, means they have authority to make contracts and compacts with the Federal Government and its agencies.

Under Tulalip's PL 638 compact, although the grant funds are guided by IHS regulations, the tribes can determine where the funds will be most used, or what the greatest need is, as long as the funds are used for community health programs. Here at Tulalip those programs include the Karen I. Fryberg Health Clinic, the Dental Clinic and Tulalip Family Services programs.

Last year, 2013, Tulalip anticipated a \$9 million award from IHS. Due to sequestration, the final award was just under \$8.5 million, leaving a \$500,000 gap in budget, the equivalent to 10 full-time jobs. Another often overlooked piece of any grants budget is indirect costs. Indirect costs are administrative services provided by an organization (in this case, Tulalip Tribes), that support the grand funded program.

In the case of Tulalip's IHS grant, 29% of the total grant received pays for peripherals including finance services, utilities, electricity and maintenance of the facility. This means that out of a \$9 million award, only \$6 million is available to pay for health care, the rest must, according to IHS guidelines, pay for indirect costs.

Tribes that are not self-governance tribes are completely run by IHS. Rather than the tribe determining the need and deciding where to spend the overall budget, IHS determines need, creates a budget and completely administers the program with little input from the tribe.

In our fall newsletter, I was brand new to the area and spoke about our major work plan for the 2013-2014 school year. Now, although I am still rather new, I am finding my way around and meeting so many of you – and our work plan is well underway and midcourse. Our 2013-2014 work plan consisted of major focus in two areas:

the improvement of learning and teaching, and engaging for the future. In the area of student learning – we have been busy! Not only are our standards new, but as of spring of 2015 – we will have new yearly student testing as well. We will be piloting this Smarter Balanced Assessment this spring.

We are also knee-deep in

learning about our new teacher and principal evaluation system mandated by the legislature. We are finding it is extremely time-intensive, but that the conversations around student learning that are occurring as a result of this new system are indeed valuable. So, what we are teaching, how we are testing, and how educators are being evaluated are all 'under construction' and we are working hard to ensure that our students learn at the highest levels.

In addition to this core work, we are continuing to engage our community. This engagement ranges from coffee meetings in homes, to casual conversations at community and school events or in the grocery store. One formal initiative in this process of outreach was asking the voters to renew our educational programs maintenance and operations levy. This levy constitutes a full 20% of our district budget.

We also asked voters to approve our technology levy. Our last technology levy expired nearly ten years ago, and our students need to be prepared for an increasingly technological world. Both initiatives were on the February 11th ballot and both measures passed! Thank you!

Additionally, we are coming to the end of our four-year district goals, and it is time to set new ones. We want to set goals, however, based on the input of our community. Therefore, on Saturday, March 29th, we will be hosting a 'Dream Big for Kids' event. This will be one-day session where we envision what we want the Marysville School District to look like ten to fifteen years from now. Once we have this community mandate, we will determine our next set of benchmarks and goals to get us there. Watch your mailboxes for your invitation to "Dream Big for

Kids".




