

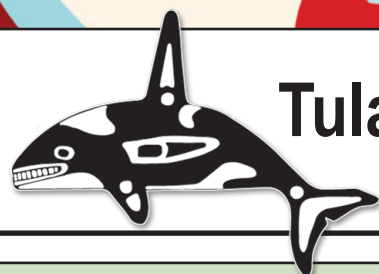

Fun and learning at Lushootseed Family Nights



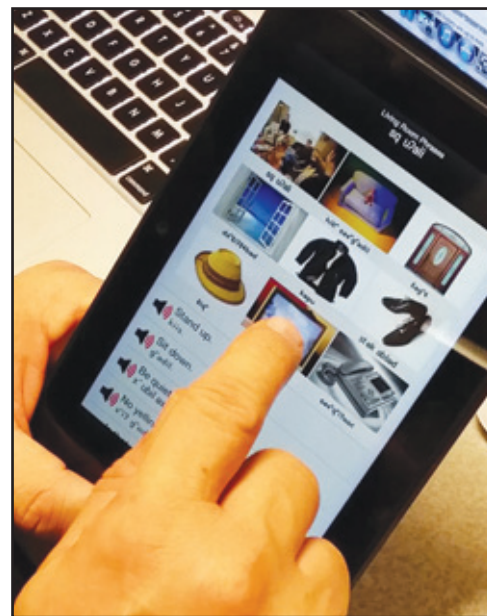

## Tulalip releases first Lushootseed speaking app

In an effort to continue the revitalization and preservation of the Lushootseed language the Tulalip Tribes Lushootseed Department has launched its first language app on the Android system.

On November 19, the app, *Lushootseed Phrases*, became available for download on mobile devices running Android operating systems 2.3 and later.

The app joins more than a dozen other language apps on Android, available for learning Native languages.

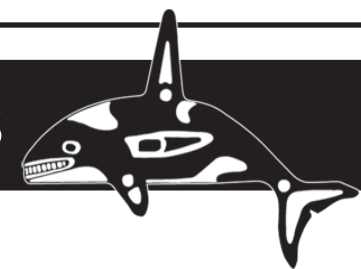

## Safeguarding the tribes most valued resource

December's famous employee, selected by beda?chelh, is Khia Grinnell, a Jamestown S'Klallam tribal member that works as a reservation attorney at Tulalip. Over the last two years, Grinnell has been working within the Tulalip Tribes as an attorney, representing beda?chelh in court. She mediates between the court, beda?chelh, and the families; together they work to protect tribal children by pursuing the best interests of the child, while reuniting families.

"I see a variety of situations. Your heart can't help but to go out to somebody who's in that situation, because we've all seen it personally in family and friends. Seeing them succeed is a success, and if the parents can't succeed, seeing family come forward to take care of the child, that's the next best thing."

"I just always wanted to help people," Grinnell said about why she became an attorney. During high school she worked for her tribe, Jamestown S'Klallam, and was invited by Vice Chairman Liz Mueller to attend the tribal

council meetings. "I attended all through high school; I liked the variation that law could provide." After attending tribal council and witnessing the many uses of law, she pursued an education in law at St. Lawrence University and Arizona State University.

When she isn't in court, Khia works on various board-appointed projects such as foster care licensing, and helped to update the Youth Code; a Tulalip Tribal code that views Indian children as the tribes most valued resource.

Her daily inspiration to do her best comes from being able to, "make my grandparents proud and make sure that Indian Country thrives, whether individually or as tribes."

The best part about her job, according to Grinnell, is helping tribal families and seeing the parents, or guardians, get clean and sober and reuniting them with their children. The motto that helps her to persevere throughout her daily struggles is, "If I fail it's better to get up and try another way. It's not about failing; it's about how you recover or react to the failure."

"This is our flagship app. It basically works off something that we started a few years ago," said Dave Sienko, Lushootseed media developer.

"We use the simple basic technology with push button sound card where you can push a button and hear the word, and then see it on a screen. People liked those and a lot of people utilized them, but with the change in technology it just seemed like the best way to go is with an app," continued Sienko about the switch from the software program they used on Nintendo DS game systems typically used during the annual Lushootseed Language Camps.

Using a simple format, users of the Lushootseed app are able to browse through category topics that include phrases for the kitchen, living room, bathroom and bedroom. The app also includes greetings and introduction phrases. By a simple push of a speaker graphic, users can hear a clear pronunciation of the phrase or greeting.

"I wanted something that was simple to operate," explained Sienko about the app's design. "We tried to do some sentences that could easily be replicated by just substituting a word, such as hand me this \_\_\_\_.

Those types of things. There are several examples where the name of a person is just left blank."

Many users will recognize the voices of the speakers, as many of the Lushootseed department's teachers are featured in the app, something Sienko said makes the app unique.

"I did all the coding myself, but when it comes to the app, the teachers gave so much of the input. They would say, hey we wouldn't say it like this, or this is pronounced wrong. They really worked to have Tulalip style of speaking represented in the audio."

While some graphics have been incorporated into the app, the focus is on the audio. "Sound is important, especially with the language. There are a lot of nuances with the language that you have to be able to hear, so the audio has to be really good," said Sienko.

In addition to audio, Sienko quickly points out that the app isn't meant to replace learning the language, but is built as a resource tool to supplement the Lushootseed Family Night classes the department holds, where the curriculum is focused on teaching how to converse in Lushootseed.

“The goal we have for this app is for the user to use it to expand their use of Lushootseed in their homes. Over the next year I plan to release four more apps. Ones that concentrate on immersion technology, such as when you are in the kitchen you can use

Lushootseed,” explained Sienko.

One of the app’s biggest successes is the fact it does not require Internet or cell phone data to run once it has been downloaded. Sienko reports this was something that was part of the design plan from the early stages.

“Developing it, the first thing I ran into was having the audio embedded in the app, instead of via the Internet. A lot of times you have to have a great Internet connection to use an app so I had to have something that was embedded, because let’s face it, I have yet to go to a tribal reservation that has decent cell phone coverage in every area. That is everyone’s complaint.”

“The app is larger than what I would have liked but to make it usable, it had to be that way; it makes it a lot more accessible and we hope to keep expanding on it,” said Sienko. “I think all

too often languages get put into more of a cabinet to be looked at, and the idea for our department is, we want it to be used and get it out there, and have the accessibility for people to use it.”

Plans to release the app on Android-operated tablets is in the designing phase, as is an ios version of the app available through Apple iTunes. Sienko is also working to make the app available on Kindle devices in the near future.

combined Quil Ceda and Tulalip Elementary school by the National Education Association (NEA) and Washington Education Association (WEA). Both campuses, earmarked as priority schools, exemplify a joint commitment of students and teachers to academic achievement. The incredible turn around embodies the intent of the School Improvement Grant (SIG grant) they received as schools in need. A change in national perspective led to the development of the grant which catalyzed the positive turn around at these schools.

“Because of previous legislation, schools that needed assistance were labeled failing,” said Kim Mead of the WEA, referring to No Child Left Behind, which decreased funding to schools that did not meet state and national standards. “We changed our perspective, failing schools came to be seen as priority schools.”

In the last five years, 97 Washington schools were considered failing and had their funding cut. With the new perspective of those schools as a priority, the US Department of Education created the SIG grant in 2010, providing three-year funding to schools on the national priority list. Of the 60

eligible schools in Washington state that applied, 28 were awarded grant funding.

The SIG grant is conditional funding, giving four plan options to bring schools up to standard. These options are closure and transferring students to high achieving schools, turnaround by reorganizing current school curriculum and staff, transformation through a change in leadership and instruction, and restart which would convert public schools to charter schools, which were illegal in Washington state until 2012. Of the 28 Washington priority schools awarded grants, now specified as SIG schools, one school closed, 23 selected transformation, and four opted for the turnaround, including Totem, and Quil Ceda and Tulalip.

Led by the teachers, these schools developed their staff and curriculum to change the professional practices in their schools. Through the SIG funding, Totem purchased laptops for each grade in order to assess individual understanding of course materials. They developed a home visit program so that teachers have the necessary skills to bring school needs into the home, while addressing home issues, not as a means to lower standards or make

accommodations, but to understand how to balance the school work with home life. The most prominent demonstration of home life coming to school is the morning assembly at Quil Ceda and Tulalip, which incorporates traditional values into the school day. The NEA observed the assembly during their visit.

“I chose Washington to kick off American Education Week,” said Dennis Van Rockel, NEA president. “I hear so much about Washington, what you all are doing here, and I’m

glad to be able to come and see it first hand.”

Programs in these SIG schools that see drastic positive improvement are leeching out into other schools throughout Marysville School District.

“This is important as we get ready to roll out the Common Core curriculum, which is the national standard equivalent,” said Tulalip/Quil Ceda teacher, George Camper.

2013 marks the final year of the SIG grant funding, which

means the priority schools were evaluated nationwide. Totem, and Quil Ceda and Tulalip not only outperformed all others in the state, they outperformed the nation's priority schools. In recognition of their achievement, each of their libraries were given \$500, and each school was given a banner acknowledging their accomplishment.

The nation is now looking to Washington as an example for the work Totem, and Quil Ceda and Tulalip schools have done. They have set a standard for priority schools nationwide, which is described in a packet titled 'Improving Student Achievement in High-Poverty Schools: Lessons from Washington State,' that outlines how these schools successfully turned around from persistently low achieving to high achieving.

"We call ourselves language warriors and anyone who comes to help out is a language warrior too," said Lushootseed language teacher, Natosha Gobin. Family night events have been taking place since the early 90's and are gaining momentum as more children and adults become dedicated to learning the language.

Family night is offered every season except summer, which is for language camp. The seasonal classes are the "perfect opportunity for youth who do not receive regular Lushootseed classes, and for parents and youth in the Montessori/ECEAP language programs, or anyone else who would like to start using Lushootseed on a daily basis," explained Gobin.

Lessons teach basic

phrases, words, songs and prayers that can be used in everyday conversations, and materials are provided free of charge for attendees. At the first two meetings, the department provides dinner, but the following meetings will be potluck meals. Future Family Nights will be held at Tulalip Hibulb on Wednesdays from 5:00 p.m. to 7:00 p.m. Regular attendance is not required.

Fall Lushootseed Family Nights are November 20, 27; December 4, 11, 18 and January 8, 15, 22, 29.

# General Manager's Report

## Holiday Closure



Good afternoon,

As a tribe, we know the importance of family, to encourage our employees to spend time with their loved ones, and as a way to save money, Tulalip Tribal Government offices will be closed from December 24<sup>th</sup> through January 1<sup>st</sup>. In looking at historic leave usage, almost 60 percent of employees already take leave during this period. We'll be saving funds by not heating or powering buildings, and we'll see additional savings in areas such as mileage and gas for vehicles. I'll be excited to see and share the final numbers with you next year.

Essential staff will continue working. The Tulalip Police will ensure that there are sufficient dispatch staff and commissioned officers to keep our Reservation safe. The Karen I. Fryberg Health Clinic will be open half days, closing only on December 25<sup>th</sup> and January 1<sup>st</sup>,

in order to keep our people healthy. Utilities and Roads will have skeleton staff on board to ensure that operations continue. We are compiling a list of numbers and resources that you can contact if you have an emergent need during the closure.

Although essential staff will be at work, non-essential staff that would normally provide services will not be working this year. That means that Youth Services will not be providing winter break field trips and activities. Instead, they are putting together a packet of events and activities that you can do with your children. This is a great time to rekindle family traditions, start new traditions and simply connect with the people you love.

Because the tribal offices will be closed, staff will not be on hand to answer phone calls, or conduct day-to-day business. Please take a moment to think about the services

that you access on a regular basis. Is there something you can take care of now? Do you need to review any of your accounts with the tribe? Sign up for a program, or pay a bill? This is a perfect time to take care of any business that you need done before the closure.

We appreciate your patience and understanding while we are closed. We're blessed to have the flexibility and the support of our board and community to do these kinds of proactive efforts. This closure is one of the numerous strategies we're putting in place to make smart use of the money we are entrusted with and to continue providing a family friendly environment for our employees.
