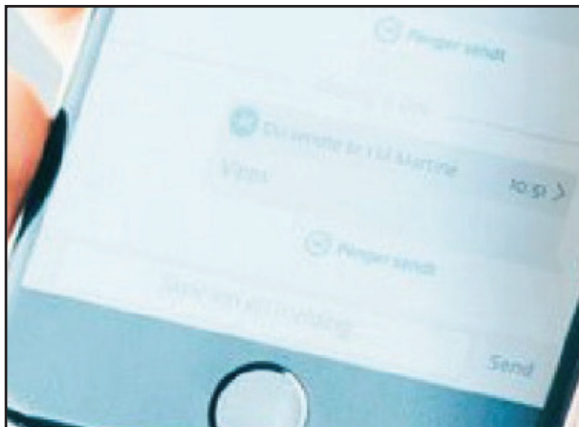
Homemade mask maker Georgina Medina is hustling and bustling... and potentially saving lives

With orders to stay at home and stay safe due to the Covid – 19 virus; the Election Committee, non-elected Board Members, and staff have created an alternate plan for the 2020 election; in a safe manner for membership. The annual general council along with elections for March 21, 2020 was cancelled and posted pone to a later date.

The 2020 election will be absentee ballot ONLY by request. All request to obtain a ballot must be submitted by April 17th. The ballot request form is on the backside of this letter & mailed out to all tribal members who are eligible to vote as of 3/21/20; this form is also available on the Tulalip Tribes website <https://www.tulaliptribes-nsn.gov/Dept/Elections>. The Election Committee is making every effort to reach out to our eligible voter however; if the ballot request form is not available, you can write a letter with your name, enrollment number, email, phone and address and SIGNATURE. This practice is not common but due to the circumstances, this process will be allowed. Your signature is very important please do not forgot. NO signature NO vote.

To maintain the integrity of the 2020 election all ABSENTEE BALLOTS are to be requested; this is a standard procedure. We encourage each eligible Tribal Member to actively participate. Ballots must be mailed or dropped off by May 11th at 4:00pm at the UPS store (8825 34th Ave NE, Tulalip WA 98271). A pre stamped envelope will be included in the ballots packet, no postage needed.

May 12, 2020 at 1:00pm the election committee will announce the election results through Tribal media and iAmTULALIP.com.

The 2020 General Council gift is an umbrella & cooler with a custom design by Ty Juvinel. Every eligible Tribal Member who submitted their ballot request form will receive a gift. The gift will be stored for a later pick up.

If you have already voted by absentee, your VOTE is still valid. Please take the time to make your vote count.

The Election Committee is taking all safety precautions to safeguard our membership and to execute the 2020 Board of Directors Election.

**2020 Board Elections:
Approving Absentee Vote by Mail Election Schedule and Procedures**

WHEREAS, the Board of Directors is the governing body of the Tulalip Tribes under the Constitution and Bylaws of the Tribe approved by the United States Commissioner of Indian Affairs and the Secretary of the Interior on January 24, 1936, pursuant to the Act of June 18, 1934 (48 Stat. 984, 25 U.S.C. §476); and

WHEREAS, the Board of Directors is empowered by Article VI, Section 1 (L) & (R) of the Tulalip Constitution to take necessary actions to protect the health and welfare of the Tulalip community, and

WHEREAS, at the March Regular Board meeting, the Tulalip Board of Directors issued a Declaration of Emergency on the Tulalip Indian Reservation as a result of the outbreak of novel coronavirus (COVID-19) that has been declared a worldwide pandemic, and

WHEREAS, by prior resolutions, the Board of Directors postponed the 2020 Board Elections and Annual General Council Meeting due to this unprecedented state of emergency, and

WHEREAS, the Tulalip Constitution, Article III, Section 4 provides that board members shall hold office until their successors are duly elected and qualified, and

WHEREAS, the Tulalip Constitution, Article IV, Section 5 provides that all elections shall be held in accordance with the rules and regulations laid down by the Board of Directors, and

WHEREAS, because public gatherings have been prohibited due to the public health emergency, the board has found it necessary to adopt special absentee vote by mail election procedures for the 2020 board elections.

NOW THEREFORE BE IT RESOLVED that:

(1) The Board of Directors hereby establishes rules and regulations for the 2020 Board Elections pursuant to Article IV, Section 5, such that:

- a. The 2020 Board elections shall be conducted by absentee mail in ballot.
- b. The Board approves the attached 2020 absentee vote by mail election schedule and procedures for the 2020 Board elections.
- c. Board members whose positions are currently scheduled to expire in April of 2020 shall continue to hold office as Tulalip Board members until the re-scheduled election results are tallied and certified and the newly elected Board members are sworn-in in May of 2020.
- d. The rescheduled 2020 General Council meeting date for April 11 is hereby canceled until further notice. Notices regarding the rescheduled General Council meeting date will be communicated to the membership through Tulalip media and social media sites.
- e. Current Board officers shall remain in place until officers are selected by the General Council when the General Council meeting is re-scheduled. If Board elections result in Board officer vacancies, the Board shall select interim Board officer(s) to fill the vacancies until the date of the re-scheduled General Council meeting.

ADOPTED by the Board of Directors of the Tulalip Tribes of Washington at a special meeting assembled on the 4th of April 2020, with a quorum present, by a vote of 5 for and 1 against and 0 abstaining.

Today, we received word that one of our Tulalip Tribal Police officers has tested positive for COVID-19. Our hearts go out to the officer and the officer's family. While this is scary, the Tulalip Tribal Police Department has prepared. It has procedures in place to minimize the risk to co-workers and the public.

The officer's last work shift ended Saturday morning on April 4, 2020. The officer is now self-quarantined at home. Another officer who had traveled in the same vehicle on Friday is also self-quarantined.

Our police have an adequate supply of N95 masks, gowns, eye protection, gloves, and disinfectants. The staff is trained in how to limit exposure, and they know that if they are not feeling well, they need to stay home and report to a testing facility.

The Tulalip Police Department building is disinfected daily with particular attention paid to high touch surfaces and shared workspaces. The Tulalip Police Department remains in operation, and despite the risks of COVID-19, our first responders are committed to patrolling and protecting all residential areas, tribal assets, interior woodlands, treaty fishing and gathering, and business establishments.

As a reminder, you can visit our website covid19.tulaliptribes.com, for our current case count. We rely on self-reporting to provide the most accurate numbers. If you or someone you know has tested positive for COVID-19, please reach out to our Community Health Department at 360-716-5777. A Community Health nurse will provide you with information about how to protect yourself and those around you. Accurate numbers will help us keep the correct statistics about how COVID-19 is affecting our community.

Masks from front page

While countless people are scrambling to find paying jobs or anxiously awaiting unemployment benefits to kick in, one Tulalip citizen's ingenuity and craftsmanship has allowed her to carve out a critical position in a very niche, yet suddenly surging, market place. Georgina Medina, tribal member and devoted mother of five, is creating stylish, protective face masks to combat the coronavirus.

First, we must interrupt this article with an important message from the Centers for Disease Control (CDC).

"The CDC continues to study the spread and effects of the novel coronavirus across the United States. We now know the virus can spread between people interacting in close proximity even if those people are not exhibiting symptoms. In light of this new evidence, CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies).

"It is critical to emphasize that maintaining 6-foot social distancing remains important to slowing the spread of the virus. CDC is additionally advising the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure."

That message comes directly from the CDC's own website in an April 3rd announcement ending the weeks' long debate about whether a non-medical grade face mask can minimize the transmission of coronavirus. The answer is a resounding 'Yes, it can.'

Now, back to Tulalip tribal member Georgina and her homemade mask making. It was in early March, back before COVID-19 had really entered the everyday lexicon and long before the CDC recommendation, that she had the foresight to

hone her craft making skills. A high-risk family member had started to wear a mask as a preventative measure and Georgina thought to herself, "I wonder how difficult those are to make?"

The inquisitive 36-year-old then took to YouTube and watched a video tutorial on cloth mask making.

"It seemed easy enough, so I tried a few different methods on my sewing machine that my boyfriend bought me for Christmas," recalled Georgina. "It was quite an experience. I messed up a few times until finally finding a way that worked for me."

When she perfected her fabrication method, she made a mask using an eye-catching fabric design and posted it on Facebook. The response was incredible. Immediately, she received comments and messages from prevention-minded individuals offering to purchase one of her homemade creations.

"I learned quickly that there was a definite need for these types of masks. After I posted that picture the requests just kept coming," said Georgina. "Because I purchase all the materials and do all the necessary cutting, sewing and ironing by hand, I decided to charge \$10.00 per mask. It's been one journey after another to my favorite store (Jo-Anne's Fabric in Smokey Point) to pick out fabrics ever since."

From the time when she made that initial Facebook post in March, the terms 'coronavirus', 'COVID-19' and 'high-risk groups' have dominated the media landscape. COVID-induced fear and panic has spread like wildfire across not just the nation, but the entire planet. Globally, there are now 1.4 million confirmed coronavirus cases and 85,000+ deaths attributed to the pandemic. The statistics continue to grow at an exponential rate, resulting in health experts no longer simply urging preventive measures, instead they are demanding the use of social distancing and mask wearing when in public.

As a result, Georgina's 100% double-layered cotton fabric masks are Earth-friendly not only because they are washable and reusable, but

they also potentially save lives by mitigating risk of coronavirus transmission.

"If my masks help people and allow some to feel safe going in public like on essential trips for supplies and groceries, then I'm glad I can be a part of that," said Georgina when considering her masks' positive impacts. "A mask is not a cure, but it is a preventative measure and that's better than nothing at all. The

CDC has recommended everyone to start wearing them, so I'll keep making them until we are virus free."

To date Georgina's surging sales have led to a customer base spanning the entire west coast. She has shipped her masks to consumers from Alaska to California, the Dakotas and throughout Canada. There's even been repeat business from a customer in Texas.

"I have an impaired immune

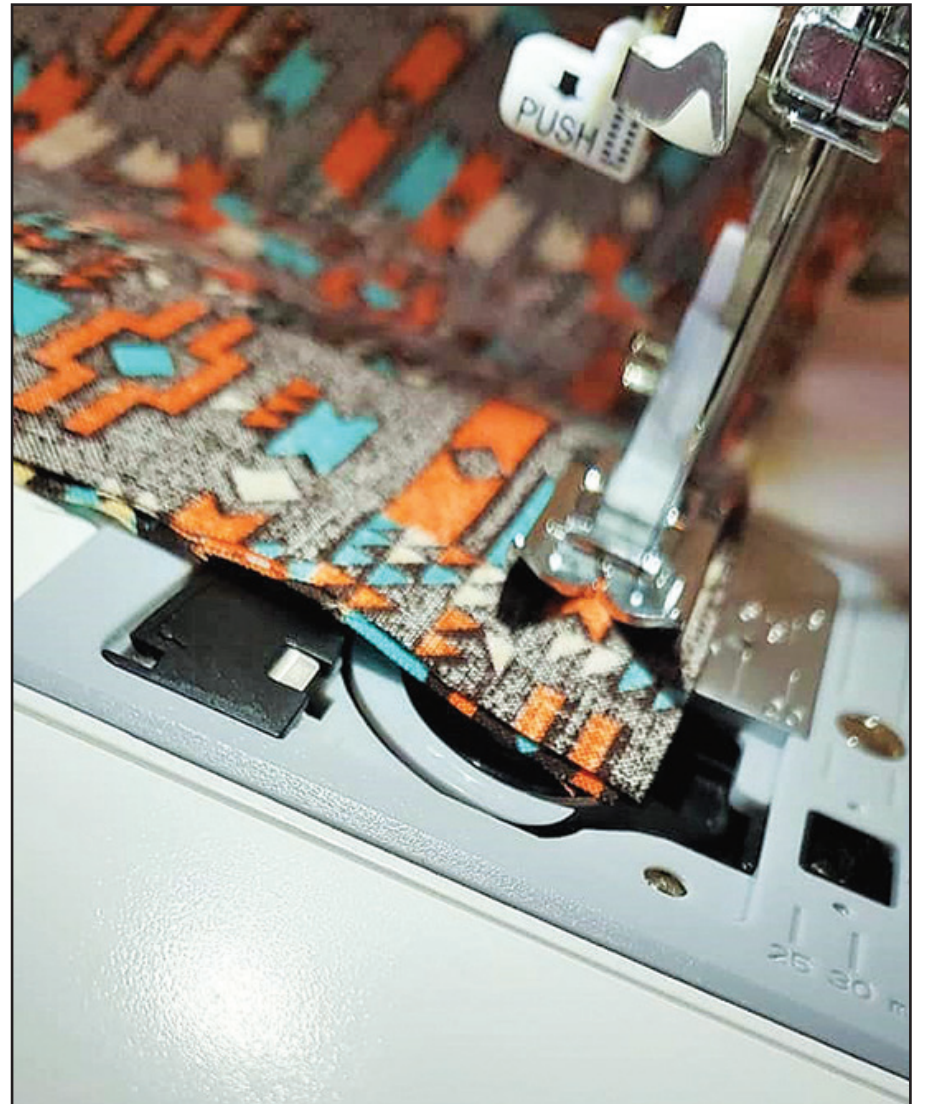
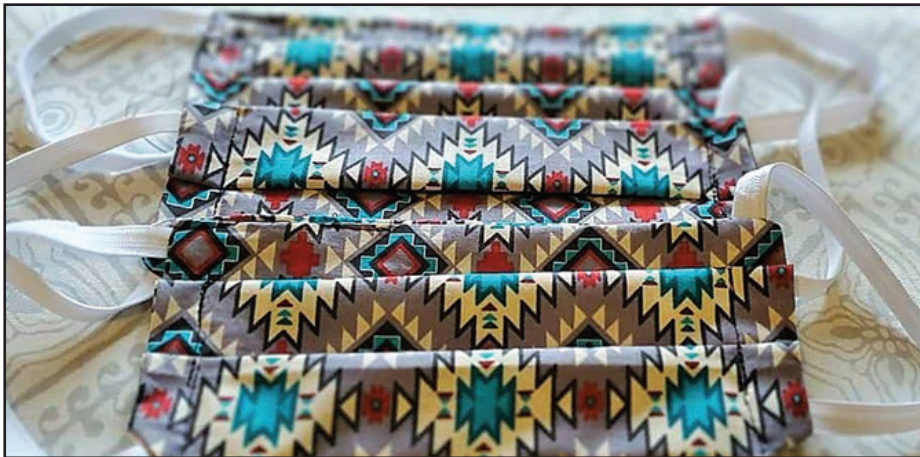
system and was terrified to leave the house," shared customer Callisto. "Now, with this mask and an added filter on the inside of it, I can go get groceries and not be so afraid. [The mask] is beautiful, fits well, and is so needed. And a bargain for the price!"

She delivers locally, offers shipping to those who require it, and even takes custom orders for customers desiring a specific fabric

design.

"A huge thank you to those willing to support me and my 5 children at this time," said the diligent mask maker before hustling back to her sewing machine. She just received another order to fill.

TULALIP HEALTH CLINIC TELEMEDICINE



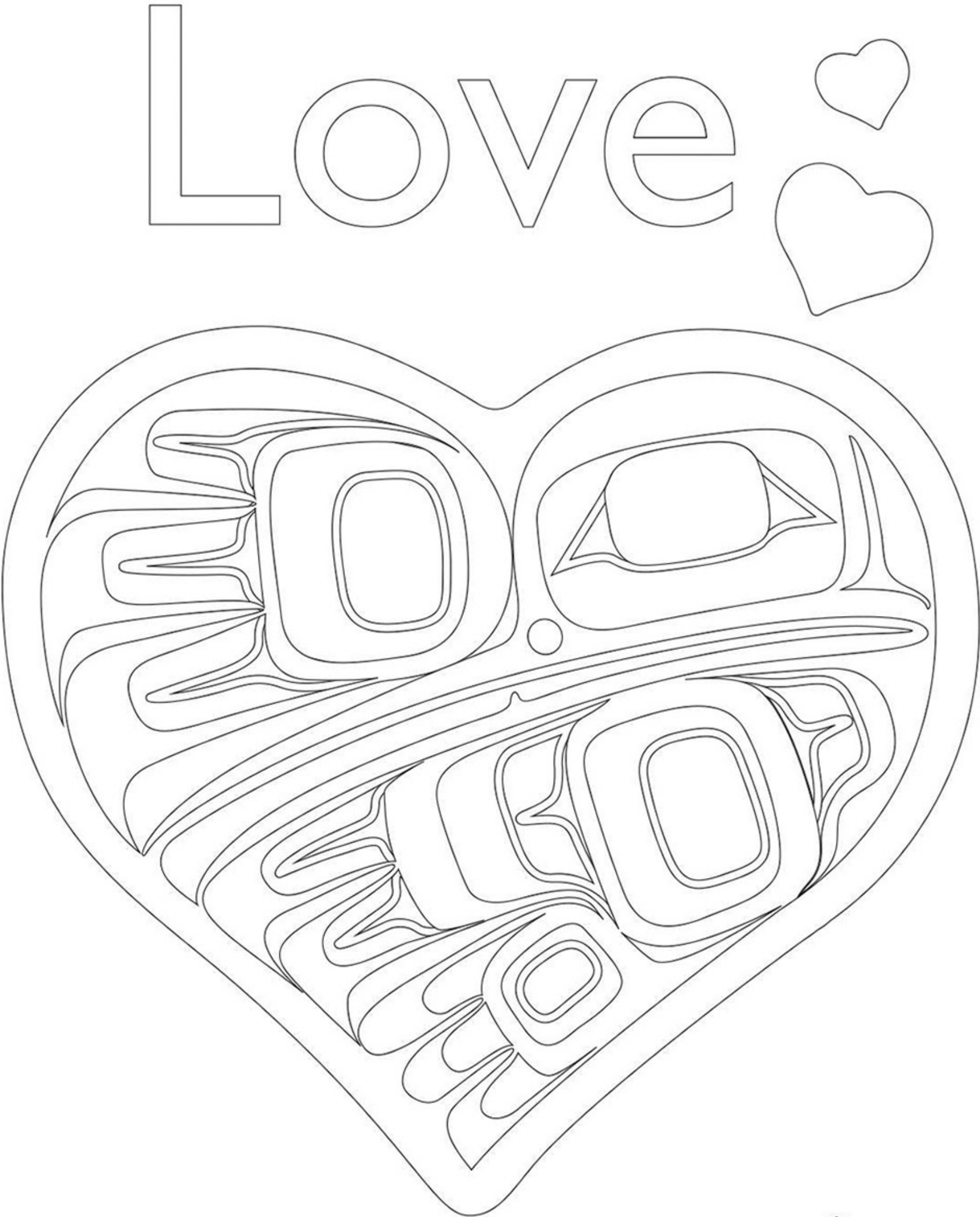

You will need a smartphone with a camera, laptop or tablet for this visit.

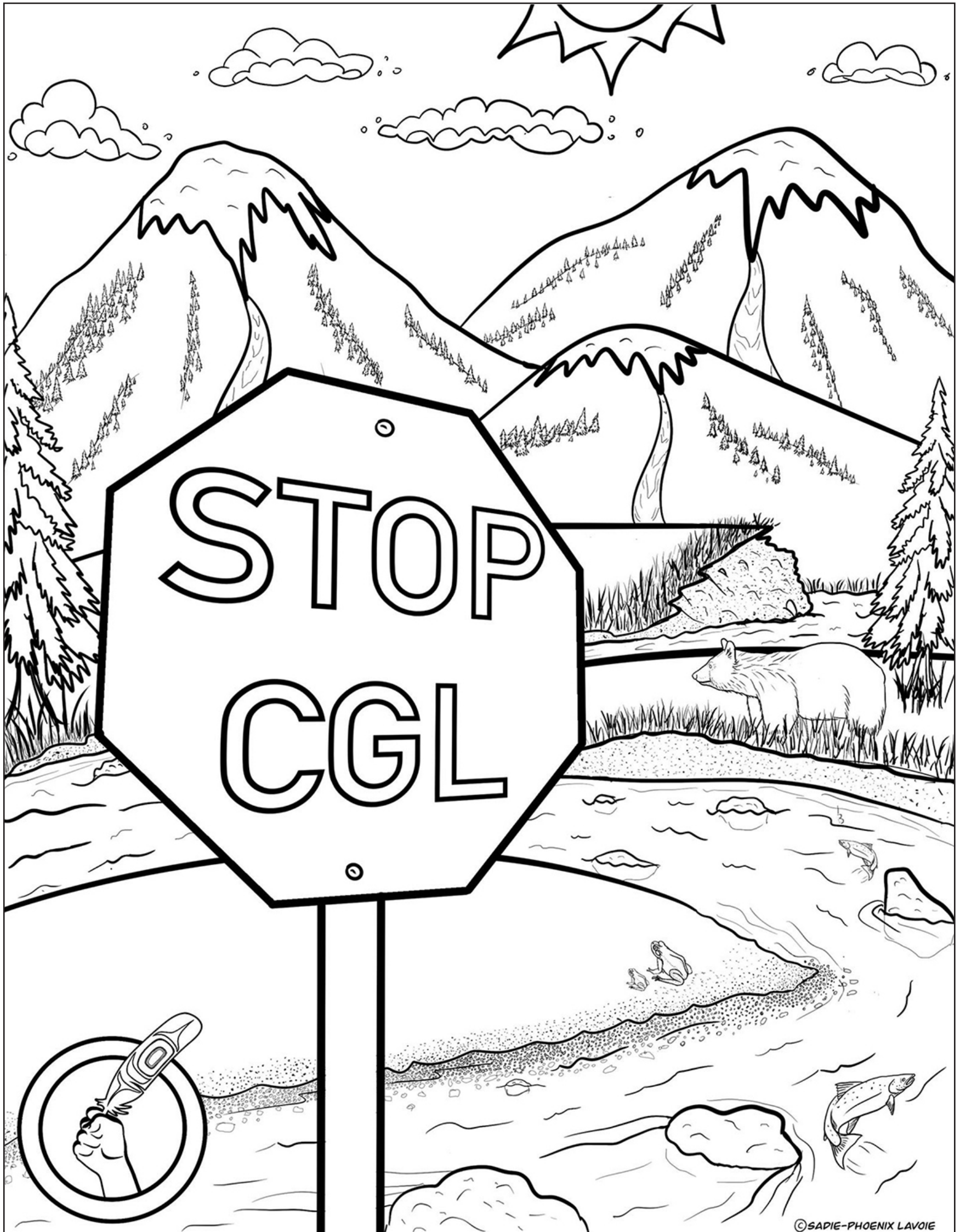
